a. Road Department Report

The Road Superintendent reports that Spring run off created some washouts and gravel has been purchased for areas on North Quarry Road. Roy's Bridge is ahead of schedule because of the nice weather. The City of Temiskaming Shores retendered the joint calcium tender. Pollard was awarded the tender with a 2-cent increase from the previous tender. The increase is due to the new gas tax. Township of Harley might need to start looking for a ½ ton next year. The man door into the shop was replaced with a used door and a new lock has been installed. The Dump has received lots of fill from Roy's Bridge which will help save on closure costs. We will need to purchase culverts.

b. Fire Department Report

The Fire Chief reports that the Fire Department responded to a call on Highway 11 South of Maybrook Road on March 28th, for a tree on power lines. The engine in the tanker has been changed. Oil leak has been noticed. Todd Maguire has shown interest in coming back as a fire fighter. Online training is ongoing and outdoor training will commence shortly. A few fire permits have been issued. Residents are asked not to burn when the wind is high. Fire restriction in effect as of April 12th. The department has applied for a grant that will go towards online training, a new laptop and additional training for members. The Deputy chief has asked for a leave with an undetermined return date. Meetings will be the first Wednesday of the month for business and the third Wednesday for practice.

Council inquired whether the fire department should appoint a replacement for the deputy chief while on leave. The Fire Chief informed council the current captains were willing to share the extra workload while the current Deputy Fire Chief is on leave.
