7. Reports from Staff & Others

a. Road's Department Report

The Road Superintendent reports that all the roads crew have been vaccinated for COVID-19. In preparation for dust control, calcium has been ordered. A culvert collapsed on Howard Line Road and will need to be replaced. The roof on the municipal hall should be replaced shortly. The garbage at the landfill has been packed, the wood pile has been pushed up and a new trench has been dug. Road staff replaced one culvert at the landfill and still have two more to be done at a later date. The township is still looking for a Summer Student.

b. Fire's Department Report

The Fire Chief reported that there is a water leak in the roof of the Fire Hall.

The Fire Department responded to two calls in April. April 10th at Coutsville road for an uncontrolled grass fire that spread into a scrap yard, and on April 22nd for a smoke investigation for a large outside fire.

The Fire Department has had two new members join the department, Erik Laplante and Kyle Breault. They are both employees at Georgia Pacific in Englehart and are on their employer's fire team. They will both be on a three-month probation but will be a big asset to the fire department.

Last month with the dry weather the Fire Department had put on a municipal fire restriction. The Fire Department had two reports of burning during the restriction. The fire call on April 22nd is under investigation.

The grant money from the Ontario Fire Marshal was approved. A new Laptop has been purchased with the funds.
