a. Jerramy Peddie - Property Zoning Amendment

Jerramy Peddie addressed Council and asked if they could change the rules so he could have a third dwelling unit on his property which is zoned as "prime agriculture". He said he has inquired if this was permitted with municipal office staff several times over the last 5 years and was told no each time. He currently has one (1) dwelling and one (1) "granny suite" on the property which is permitted under the Zoning By-Law amendment 2016-20. Council outlined that there is a process to be followed when applying for a building permit which includes a zoning by-law review. Jerramy quoted sections of documents he found online regarding the provinces position on allowing a third units on a property regardless of local zoning rules. He also outlined that the building inspector had visited the property and gave him a document. The Clerk-Treasurer outlined that the provinces position on three units does not apply to his property as it is not a fully serviced lot (no municipal water or sewer), but will seek the specific sections of the province's planning statements from the municipal planner and provide them to Jerramy for further clarification.

a. Roads Department Report

The Road Superintendent reports that March was extremely busy with multiple snow falls and thaws. The grader was used for 82 hours, the loader 83 hours, Truck #6 was used for 51 hours, and Truck #8 was used for 70 hours. This is significantly higher than March of 2024. The Roads Department asked for patience as they deal with the irregular weather. Half load season will be in affect in Harley staring April 9th. The transition at the landfill is going well. The Road Superintendent will be attending a Weed Inspector's course this week in Guelph. Councillor Fielder inquired as to how much it costs for a full time operator and plow truck versus subcontracting out winter road maintenance. Councillor Fielder would like office staff to get numbers for comparisons on subcontracting out winter road maintenance. The Clerk-Treasurer will attempt to get quotes.

The Fire Chief Reports that they have responded to 3 calls and all went well. The Fire Department has received gloves, boots, and balaclavas which were purchased through the OFM grant. Lastly, all three trucks have had their annual safety inspections completed.
