4. Delegations:

a. ABO Energy - Timiskaming Wind Project

ABO updated Council on their proposal to install wind turbines in Harley Township. ABO held an open house on August 7th at Riverside Place in Temiskaming Shores and approximately thirty-five people attended. Aboriginal engagement has begun. Submission deadline for this project is October 16th, 2025 and successful projects will be announced in April of 2026. Additional studies would begin after that time. If an MSR is not provided in time for this bid submission, ABO would work towards submitting during the second round which will take place in July of 2026. At the open house, technical experts were available to provide lots of information which was available in both French and English. Comment cards were available to gather feedback and comments were summarized as follows:

Some attendees were interested in hosting a turbine.

Some attendees were opposed to the project.

Some comments were made about the Casey and Hilliardton Marsh. There are some studies related to the marshes that would take place once a project was awarded. It is common to have 3 years of monitoring after a project is constructed to monitor things. Open-house comments also included decommissioning the project. ABO has agreed to fund the decommissioning which is calculated and managed by a third-party engineering firm. Some of the steel would be recycled to offset the cost,

but a decommissioning fund is still implemented. It is likely that only 1 project would be approved as there is limited space on the Dymond station. Water wells were discussed, and since vibration impact from turbines is very small, they don't expect impacts. The economics of wind energy was discussed and it was noted that all types of energy are permitted in this procurement. Shadow flicker studies would be done once a project was approved and this phenomenon may only happen a few minutes a day weather depending. (brief summary only full presentation available through the municipal office)

Council was provided with an opportunity to ask questions throughout the presentation:

Q: Councillor Fielder noted more time to digest the information was preferred.

A: It is difficult to juggle the timing and the process is dictated by others, (IESO) but some preliminary studies have already been done.

Q: Reeve Archambault asked if there were specific setbacks from waterways and airports.

A: Yes, they need to be 100m away from water, and 2km from any registered airstrip which is the largest set back they must adhere to.

Q: Reeve Archambault asked about assessments and money for the township.

A: Harley can expect \$60,000/year for property tax increases which is based on City of Temiskaming Shores' tax rate and \$2,500/MW of installed capacity once turbine locations are known.

Q: Councillor Fielder asked for clarification on monies received by the Township if the turbines aren't working.

A: The community fund is based on installed capacity, not output of energy. The amount is guaranteed.

Q: Councillor Fielder asked if ABO was a Canadian Company. **A**: ABO is a Canadian subsidiary of its parent company which is German.

Q: Councillor Fielder commented that these turbines would cause vibration and noise.

A: Many studies must be done to determine if provincial criteria are met for things such as vibration and noise.

Q: Councillor Fielder asked why Harley cemetery is included in the area of interest.

A: The area of interest is large but not every parcel within its boundary is suitable for a turbine. ABO would also be happy to hear about sensitive areas to avoid such as a cemetery.

Q: Reeve Archambault asked about crown land.

A: The regulations on crown land are somewhat unclear. They aim to avoid prime agriculture wherever possible. Different provinces have different rules on crown land. A typical footprint of one turbine is 1 acre

so farmers are generally okay with giving up this amount. It would also give them financial stability. Landowners must agree to host a turbine.

Q: Councillor McNaughton asked if they accounted for how close to the grid they are.

A: Yes. ABO is looking at this area because it is close to the grid and there is room on it.

Q: Reeve Archambault commented that the township doesn't have the staff to accommodate this project.

A: The timeline that has been set by the IESO is very short which is unfortunate for all involved. A municipal support resolution (MSR) just says that you are okay for them to submit a bid. Part 1 of the AIA must be completed before they can seek a bid.

Q: Councillor McNaughton asked how many out of the 20 turbines would be in Harley.

A: Approximetly 5 to 7.

ABO reiterated that wind energy takes up the least amount of land compared to other energy producers. ABO is asking for Harley to decide on an MSR as soon as possible so they can be ready to submit their bid for October 16th 2025. They would be happy to return for a Special Meeting as well.

AND WHEREAS the Council has determined that the potential risks associated with such a development coupled with the Municipality's current administrative limitations outweigh any anticipated local benefits at this time;

AND WHEREAS following a thorough review of available information, community input, and potential impacts, the Council has concluded that the establishment of industrial wind turbine infrastructure within the boundaries of Harley Township is not in the best interest of the Municipality at this time;

AND WHEREAS the Council appreciates the Province of Ontario's approach in granting municipalities the authority to determine whether renewable energy projects are appropriate for their local communities, thereby respecting local autonomy and community-specific considerations;

NOW THEREFORE BE IT RESOLVED that the Council of the Corporation of the Township of Harley does not support the installation of industrial wind turbines within its municipal boundaries at this time; and

BE IT FURTHER RESOLVED that this position be formally communicated to the Townships receiving shared administrative services through the Township of Harley, the Township of Harris, The City of Temiskaming Shores, as well as to any current or prospective proponents of industrial wind energy projects, and that the Municipality advocates for the right of local governments to retain decision-making authority over renewable energy developments within their jurisdictions.
